At any airport open to public air traffic, services provided to users and the public are subject to remuneration through fees collected for the benefit of the operator providing the service.

Based on a program communicated by the operator, XCR AIRPORT may apply tariff discounts depending on the volume of activity or for the initiation of new regular or charter routes (incentive measures, SGHA).

### REFERENCE TO IATA SGHA (2025) "AHM 810 MAIN AGREEMENT"

Unless otherwise agreed, the General Conditions of XCR AIRPORT are governed by the 2025 version of the Standard Ground Handling Agreement (SGHA) "AHM 810 Main Agreement" established by the International Air Transport Association (IATA) as published in the Airport Handling Manual.

### PROVISIONS APPLICABLE TO AERONAUTICAL SERVICES

## Beneficiary's Fleet

## INFORMATION, TERMS & CONDITIONS

The beneficiary is responsible for informing XCR AIRPORT of any changes to their fleet for aircraft using or likely to use Vatry Airport: purchases, sales, leases, rentals, modifications to aircraft characteristics, etc.

The beneficiary may request adjustments to invoices already issued. Changes will only take effect from the date of receipt by the airport of the notification of modifications or the airworthiness certificate.

### **VAT Exemption Declaration**

All rates are presented excluding VAT.

VAT is charged at the standard rate in force (20.0% as of January 1, 2014).

The VAT application regime for airport services and ground handling services is defined by the Finance Act of December 31, 1995, summarized below:

French licensed airlines ( $^st$ ) conducting less than 80% of their traffic internationally: Subject to VAT

French licensed airlines (\*) conducting 80% or more of their traffic internationally: Exempt from VAT

Foreign licensed airlines and foreign state aircraft used for declared missions: Exempt from VAT

Private aviation, business aviation, and aerial work companies: Subject to VAT

French and foreign military aircraft, French and foreign state aircraft: Subject to VAT



(\*) Companies defined in Articles L.6412-1 and L.6412-2 of the French Transport Code.

Exemption conditions will be applied in accordance with the General Tax Code in effect on the date of tariff application (Article 262, Paragraph 4, Section II), as follows:

"French companies listed in Annex A and all foreign companies, except those listed in Annex B of the regulation, are no longer required to issue a certificate. Only French companies not listed in Annex A and foreign companies listed in Annex B that wish to benefit from this exemption must provide Paris Vatry Airport with a valid certificate for the current year."

his document certifies that services to or from foreign destinations or overseas territories (DOM-TOM), excluding mainland France, represent at least 80% of the services operated by the beneficiary (Article 262 of the General Tax Code). The beneficiary commits to sending this certificate to Vatry Airport by January 20 of each year at the latest for application starting January 1.

If this certificate is not provided, Vatry Airport will issue invoices to the beneficiary applying the applicable VAT rate. In such cases, the beneficiary cannot request adjustments for invoices already issued. Changes will only take effect from the date the certificate is received.

For aircraft or flights operated on behalf of another company, the VAT application depends on the tax status of the company being invoiced for airport services.

### INVOICING, ADVANCE PAYMENTS, PAYMENT METHODS, AND DEADLINES

#### Invoicing

### INFORMATION, TERMS & CONDITION

If payment is not made immediately by the beneficiary whose aircraft uses the airport during the Operating Office's opening hours, the invoice will be sent to the beneficiary, including an additional flat fee of 10% for administrative costs. This flat fee does not exempt the beneficiary from potential collection or legal fees as outlined below.

Non-aeronautical fees are payable upon receipt of an invoice issued by the airport.

### **CLAIMS AND RECOVERY**

#### CLAIMS

Claims do not suspend payment obligations.

#### RECOVERY

In case of delayed payments, the Public Management Establishment of Vatry Airport:

- -Reserves the right to demand immediate payment of all invoiced services.
- -May apply late payment interest at a rate equal to three times the legal interest rate.
- -May charge a flat fee of €40 for collection costs.
- -May calculate additional interest based on the European Central Bank's interest rate plus 10 points.
- -May, upon simple formal notice, invoke any established guarantees or provided securities.

#### **GUARANTEES AND SECURITY DEPOSITS**

All users must provide sufficient financial guarantees based on the estimated traffic, the amount, and the duration of the ground handling contract or occupancy agreement.

### INFORMATION, TERMS & CONDITION

Thus, any regular airline serving Vatry Airport must provide a security deposit equivalent to one month of estimated aeronautical charges and handling costs.

#### DISPUTES

At the discretion of Vatry Airport, disputes may be handled as follows:

1- Implementation of the procedure under the French Transport Code

"Article L.6123-2: After a formal notice to the debtor to regularize their situation has failed, a request for the precautionary seizure of an aircraft operated by the debtor or owned by them may be filed with the judge at the place of execution by the authorities in the following situations:

The Minister of Transport,

The airport operator, in cases of non-payment or insufficient payment of airport charges,

The Airport Noise Control Authority, ...

The judge's order is transmitted to the airport's air traffic authorities for the immobilization of the aircraft. The order is notified to the debtor and the aircraft owner if the debtor is the operator. The costs incurred by the precautionary seizure are borne by the debtor. Payment of the amounts due leads to the lifting of the seizure."

2- General legal procedure

Any matter relating to the General Conditions and the services governed by them will be subject exclusively to French law. In case of dispute, only the French version of these General Conditions is legally binding.

Any disputes arising from the interpretation or execution of these General Conditions and/or the services governed by them will fall under the exclusive jurisdiction of the courts of Châlons-en-Champagne.
