The XCR AIRPORT team is at your disposal to inform you about the rates of aeronautical charges, as well as the applicable exemptions in order to take into account the information relating to your aircraft and to carry out tariff simulations.

Aeronautical charges (landing, parking, lighting and passengers) are payable for each movement by the aircraft operator.

**For safety and security reasons, aircraft assistance is mandatory (EASA certification).**

Requests for assistance must be coordinated with the airport's operations office (contact at the end of the document).

**All rates are expressed in euros excluding taxes.**

The weight of the aircraft to be taken into account for the calculation of the fees is calculated on the basis of the maximum take-off weight (MTOW) shown on the aircraft's certificate of airworthiness, rounded up to the nearest ton, and/or as it appears on the VERITAS register for the current year.

## AERONAUTICAL CHARGES

---

### FLYING CLUB PACKAGE – PRIVATE OWNERS

Flying clubs as well as private owners owning aircraft **with a maximum mass (MTOW) of less than or equal to 7 tonnes of MTOW** operated exclusively for private and non-commercial purposes may opt for a fixed fee of **€590.00 excluding VAT** per flying club or per owner and per calendar year **including minimum assistance**.

This flat-rate fee includes an unlimited number of landings throughout the year.

This fee **excludes markings and parking fees**.

Each flying club and each private owner must provide the airport with proof of ownership of each aircraft when paying this flat-rate fee.

### 1. LANDING FEES

This fee is payable by any aircraft landing at an aerodrome open to public air traffic.

The following are exempt:

- ➔ Aircraft specially assigned to the travel of personalities exercising functions, the list of which is established by decision of the Minister in charge of Civil Aviation;
- ➔ Aircraft that make a forced landing at the airport due to technical incidents or adverse atmospheric circumstances;

### REDUCTIONS

---

Rotorcraft benefit from a 50% reduction in the amount of the fee (Article 5 of the Decree of 24 January 1956).

Aircraft ≤ 7 tons: the first movement will be charged a minimum of **€65** excluding tax. Subsequent movements will be charged in accordance with the above rates.

### 2. LIGHTING FEE

The fee for the use of lighting devices is payable by all aircraft taking off or landing at an airport open to public air traffic, either at night or during the day in poor visibility, at the request of the Captain or for safety reasons on the order of the authority responsible for the operation of the lighting.

### 3. PARKING FEES

The fee is payable by any aircraft parked on the areas intended for this use.

The parking fee is calculated per hour of parking based on the maximum weight (MTOW) of the aircraft.

The parking time is counted for any aircraft between the time of landing and the time of take-off, each hour started is due. Airport management establishes aircraft parking

Aircraft specially assigned to the travel of personalities exercising functions, the list of which is established by decision of the Minister in charge of Civil Aviation, are exempt.

## 5. PASSENGER CHARGES

The fee is payable per departing passenger for the use of the facilities used for boarding, disembarking and welcoming passengers. This is applied to any carrier operating an aircraft for commercial purposes, or by an aircraft with a maximum take-off weight greater than or equal to 4 tonnes that is not operated for commercial purposes.

## 6. FEE FOR ASSISTANCE TO PERSONS WITH REDUCED MOBILITY (PRM)

The fee is payable per departing passenger for the use of the facilities used for boarding, disembarking and welcoming passengers. This is applied to any passenger subject to the passenger charge.

The Persons with Reduced Mobility (PRM) charge complies with Regulation No. 1107/2006 of the European Parliament and of the Council of 5 July 2006 with effect from 1 July 2008.

## EXONERATIONS REDEVANCES PASSAGERS / PMR / LDCS

- ➔ Personnel whose presence on board is directly related to the flight in question (members of the crew operating the flight, security or police officers, cargo escorts);
- ➔ Children under 2 years of age;
- ➔ Passengers in direct transit, making a momentary stop at an airport and departing by the same aircraft with a departing flight number identical to the flight number of the aircraft on which they arrived;
- ➔ Passengers, resuming their flight after a forced landing due to technical incidents, adverse weather conditions or any other case of force majeure.
- ➔ Passengers on an aircraft conducting an emergency medical evacuation.

## AUDIENCE

### 1. STATE DUES

The use of the public space at Vatry Airport gives rise to the payment of a state-owned occupancy fee **in the form of a monthly fee of €10.65 excluding tax/m<sup>2</sup>/month** excluding rental charges.

**Rental charges (water, energy, removal of waste bins, maintenance of common areas and green spaces) amount to €6/m<sup>2</sup>/month.**

The 1st provision of the magnetic access cards is free of charge, the replacement will be charged €50.00.

Secure parking spaces for heavy goods vehicles located within the Fret 1 and Fret 2 premises are invoiced according to agreement and on prior estimate.

Details of the premises offers and their surface areas are available on request (contact at the end of the document). The terms and conditions of use in force on 01/07/2020 are applicable to occupancy agreements and are available on request (state contact at the end of the document).

#### 4. ADVERTISING DISPLAY FEES

The Public Establishment for the Management of Vatry Airport (EPGAV) makes available, within the passenger terminal, spaces for advertising purposes:

- ➔ in the form of tarpaulins (to be provided):
  - 5 spaces in the Public Hall, format of 1 space: 2.5 x 5 m
  - 5 advertising spaces in the departure lounge, format of 1 slot: 2.5 x 5 m
  - 5 advertising spaces in the arrival hall, format of 1 slot: 2.5 x 3 m
- ➔ on screens intended to display flight statuses:
  - 6 32-inch screens in the Public Hall, located above the check-in desks
  - 4 32-inch screens in the departure lounges, located above the boarding pass check desks

In the Public Hall, advertising is possible on the screens (32 inches) put into service as part of the check-in of passengers and their luggage (between 2 and 6 screens are used simultaneously depending on the volume of passengers to be handled).

In the departure lounges, advertising is possible on 4 screens (32 inches), turned on 2 hours before take-off and until passengers board. The display will be done in a grouped manner on all the screens in service, i.e. between 4 and 10 simultaneous screens. The advertising image will be shown alternately with the status of the flights.

Each communication campaign on screen is subject to:

- A first-establishment fee (technical programming costs)
- A Weekly or Monthly occupancy fee for broadcasting on screens.

## GENERAL PROVISIONS

At any aerodrome open to public air traffic, the services provided to users and the public shall give rise to remuneration, in the form of fees collected for the benefit of the operator providing the service.

**On the basis of a programme communicated by the operator, XCR AIRPORT may apply fare discounts depending on the volume of activity or for the start of new regular or charter routes (incentives, SGHA).**

## REFERENCE AU IATA SGHA (2025) « AHM 810 MAIN AGREEMENT »

Unless otherwise agreed, the General Terms and Conditions of Vatry Airport are subject to the 2025 version of the Standard Ground Handling Agreement (SGHA) "AHM 810 Main Agreement" established by the International Aviation Transport Association (IATA) and as published in the Airport Handling Manual.

## PROVISIONS APPLICABLE TO AERONAUTICAL SERVICES

### Beneficiary Fleet

It is the responsibility of the beneficiary to inform XCR AIRPORT of any changes made to its fleet for aircraft using or likely to use Vatry Airport:

Purchases, sales, rentals, leases, modifications to aircraft characteristics, etc. etc. The beneficiary will be able to claim the regularisation on invoices already issued. The changes will only be effective from the date of receipt by the airport of the notification of the changes or the certificate of airworthiness.

### VAT exemption statement

All prices are exclusive of VAT.

VAT is charged at the standard rate in force (20.0% on 1 January 2014).

The system for applying VAT on airport and assistance services was defined by the Finance Act of 31 December 1995, which is summarised below:

(\*) Companies defined in Articles L.6412-1 and -2 of the Transport Code.

The conditions for exemptions will be applied according to the instruction of the General Tax Code in force on the date of application of the tariffs (4° II of Article 262) as follows:

"The French companies mentioned in Annex A and all foreign companies, with the exception of those mentioned in Annex B of the instruction, are no longer required to issue a certificate. Only French airlines not mentioned in Appendix A and foreign companies mentioned in Appendix B, and wishing to benefit from this exemption, undertake to provide Paris Vatry Airport with a certificate valid for the current year. »

This document certifies that the services to or from abroad or the French overseas departments and territories, excluding Metropolitan France, represent at least 80% of the services operated by the beneficiary (Article 262 of the General Tax Code). The beneficiary undertakes to send this certificate to Vatry Airport by 20 January of each year at the latest for application on 1 January.

**In the absence of this certificate, Vatry Airport will issue the beneficiary's invoices with the VAT rate in force. In this case, the beneficiary will not be able to claim regularisation on the invoices already issued. The changes will only be effective from the date of receipt of the certificate.**

For aircraft or flights operated on behalf of another company, the application of VAT depends on the regime to which the company that is invoiced for airport services is subject.

## **INVOICING, DISBURSEMENTS, PAYMENT METHODS AND DEADLINES**

### **Invoicing**

In the event of non-payment in cash by the beneficiary whose aircraft uses the airport during the opening hours of the Operations Office, the invoice will be sent to the beneficiary, plus a 10% fixed invoice fee; This lump sum does not exempt from the possible costs of reminders and litigation provided for below.

Non-aeronautical charges are payable on an invoice issued by the airport.

In the event of a delay in the regulations, the Public Management Establishment of Vatry Airport:

- Reserves the right to demand immediate payment for all invoiced services;
- May apply late payment interest to sums due at a rate equal to 3 times the legal interest rate;
- A lump sum of €40 for collection costs;
- Gives the right to interest calculated on the basis of the interest rate of the European Central Bank plus 10 points;
- The guarantees provided and the guarantees provided may be called upon by simple formal notice.

## GUARANTEES, DEPOSIT

All users are required to provide sufficient financial guarantees in accordance with the estimated estimated traffic, the amount and duration of the ground handling contract or the occupancy agreement.

Thus, any regular airline serving Vatry airport is subject to the deposit of a deposit equivalent to one month's aeronautical fees and estimated assistance costs.

## CONTENTIOUS

At the choice of Vatry Airport, the litigation procedure may take the following forms:

- Implementation of the procedure provided for in the Transport Code

"Article L. 6123-2. After the taxpayer has been given unsuccessful formal notice to regularise his situation, the precautionary seizure of an aircraft operated by or belonging to the taxpayer may be requested from the judge of the place where the measure was executed by the authorities and in the following situations:

- The Minister for Transport, (...)
- The aerodrome operator, in the event of non-payment or insufficient payment of airport charges;
- The Airport Nuisance Control Authority, (...)

The order of the enforcement judge shall be forwarded to the air traffic authorities of the aerodrome for the purpose of detaining the aircraft. The order shall be notified to the person liable for payment and to the owner of the aircraft when the person liable is the operator.

The costs incurred by the precautionary attachment are borne by the taxpayer.

The payment of the sums due leads to the lifting of the precautionary attachment. »

- Procedure under ordinary law.

Any question relating to the General Terms and Conditions as well as the services governed by these General Terms and Conditions will be subject to French law, to the exclusion of any other law. Only the French version of these General Terms and Conditions is authentic in the event of a dispute.

Any dispute arising from the interpretation or execution of these General Terms and Conditions and/or the services they govern will be the sole jurisdiction of the courts of Châlons-en-Champagne.
